## **FEE FOR SERVICE STRUCTURE**

### **Strategic Plan Facilitation**

Non-partner: \$5,000

Partner: \$2,500

### **Grant Writing**

Non-partner: \$2,000 per grant + \$2,000 admin. fee per grant (if applicable)

Partner: \$1,000 per grant + \$1,000 admin fee per grant (if applicable)

### **Meeting Facilitation/Coordination**

Non-partner: \$100 base fee + \$100 per meeting hour

Partner: \$50 base fee + \$50 per meeting hour OR \$1,000 base fee for year
