# What is Economic Development and how does it benefit you?

Putting vacant or abandoned buildings and land back into productive use is a major function of economic development. Economic development also fosters the entrepreneurial spirit that resides in our creative and ambitious citizens. - Preserve positive relationship with local governments by providing updates to boards and councils when appropriate
